



## **Code Workshop: IBC Chapter 34 and Chapter 17**

*Co-sponsored by AIA Kentucky, the Code Administrators Association of Kentucky, and the Kentucky Office of Housing, Buildings & Construction.*

This workshop will provide an overview of the changes from the 2003 to the 2006 codes to increase understanding of Chapters 34 and 17. Participants will be able to identify changes to Chapter 34 in organization and code requirements and the applicability of these requirements to design, plan review and inspection of repairs, alterations and change of occupancy in existing buildings. Participants will be able to identify changes to Chapter 17 and understand code requirements for special inspections and applicability to specific projects.
